- Dogs **must** have current shots (Please present proof of vaccination at Check-In).
- Dogs must be in a stable state of health to complete the route.
- All participants **must** sign Waiver/Release.
- All dogs **must** be kept on a maximum 6 foot leash at all times.
- Female dogs in heat will not be allowed to participate.
- At the sole discretion of the event coordinator, dogs whose behavior is unruly or might prove to be hazardous to participants, other dogs or spectators, will be requested to leave the Six Flags Over Texas Wags & Flags Dog Walk.
- All dog walkers must comply with site location rules not listed above (Please refer to Six Flags Over Texas Guest Code of Conduct).

In consideration for receiving permission to participate in the dog walk event on May 17, 2015 at Six Flags Over Texas, I hereby release, waive, discharge and covenant not to sue Six Flags Entertainment Corporation or any of its subsidiaries including without limitation, Texas Flags, Ltd., Six Flags Over Texas, Inc., and their respective officers, directors, members, employees, agents or servants (hereinafter referred to as "Releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, whether caused by the negligence of the Releasees, or otherwise, while participating in the dog walk event, or while in, on or upon the premises where the various activities related to the dog walk event will take place.

I am fully aware of the risks involved and potential hazards connected with the dog walk event, and I hereby elect to voluntarily participate in the dog walk event with full knowledge that the dog walk and activities related thereto may be hazardous to me, the dogs, and my property. I further agree to work within the guidance and direction of the staff at Six Flags Over Texas. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me including my dog, as a result of being engaged in such an activity, whether caused by the negligence of Releasees or otherwise.
3. I further hereby agree to indemnify and hold harmless the Releasees from any injuries, loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in the dog walk and activities related thereto or in connection therewith.
4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge and covenant not to sue the above-named Releasees. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Texas without regard to the choice of law principles thereof.
5. In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this release for full, adequate and complete consideration fully intending to be bound by same.
