RE: POOL/SPA INVOICE AND INFORMATION

Dear Pool/Spa Owner or Operator:

This letter is to provide you information regarding the 2014 annual billing of your pool/spa. Also, enclosed is your invoice for each pool/spa in the amount of \$200.00 for an Annual Permit or \$350 for a Year Round Permit. Please submit your payment upon receipt. A reinstatement fee of \$75.00 will be added to the amount due, if payment is not received prior to June 1st.

Please note that all public pools must be annually inspected, permitted and comply with all provisions of the City of Arlington Health Chapter. Your pool must pass an annual pool inspection **before** it can open for the season. Inspections can be arranged by calling 817-459-6777. Please do not call until your pool has received its annual electrical inspection and has met all current standards.

Please be advised that your pool must be maintained by a person who has completed approved training and register that training with the City of Arlington. Enclosed is a list of agencies that provide pool operator training. Once the class has been completed, the training must be registered with the City of Arlington. The cost for registration is \$20.00 per applicant. Registration may be completed my mail. Your annual 2014 billing include the following permit and inspection fees which became effective October 1, 2010:

- Fee for the Annual Permit is \$200; this pool/spa receives an annual inspection and there is not a lesser fee for payment of invoices prior to May 1st.
- Fee for the Year Round Permit is \$350; this pool/spa receives at least 2 inspections per year.
- Fee for Re-inspection is \$150.00; this is assessed for each follow-up inspection after your first re-inspection on the annual inspection.
