**RE: POOL/SPA INVOICE AND INFORMATION 2015**

Dear Pool/Spa Owner or Operator:

This letter is to provide you information regarding the 2015 annual billing of your pool/spa or public interactive water feature (PIWF). Also, enclosed is your invoice for each pool/spa or PIWF in the amount of \$200.00 for an Annual Permit or \$350 for a Year Round Permit. Please submit your payment upon receipt. A reinstatement fee of \$75.00 will be added to the amount due, if payment is not received prior to June 1<sup>st</sup>.

Please note that all public pools/spas or PIWF must be annually inspected, permitted and comply with all provisions of the City of Arlington Health Chapter. Your pool must pass an annual pool/spa or PIWF inspection **before** it can open for the season. Inspections can be arranged by calling 817-459-6777. Please do not call until your pool/spa or PIWF has received its annual electrical inspection and has met all current standards.

Please be advised that your pool/spa or PIWF must be maintained by a person who has completed approved training and register that training with the City of Arlington. Enclosed is a list of agencies that provide certified pool operator training. Once the class has been completed, the training must be registered with the City of Arlington. The cost for registration is \$20.00 per applicant. Registration may be completed my mail. The application for the swimming pool permits and trained pool operator is available for download at: <http://www.arlingtontx.gov/health/applications.html>

Your annual 2015 billing include the following permit and inspection fees which became effective October 1, 2010:

- Fee for the Annual Permit is \$200; this pool/spa or PIWF receives an annual inspection and there is not a lesser fee for payment of invoices prior to May 1<sup>st</sup>.
- Fee for the Year Round Permit is \$350; this pool/spa or PIWF receives at least 2 inspections per year.
- Fee for Re-inspection is \$150.00; this is assessed for each follow-up inspection after your first re-inspection on the annual inspection.
