- A. Consider revisions to the Thoroughfare Development Plan to include the following:

Downgrade:

1. East Lovers Lane from South Collins Street to Sherry Street to a local street.
2. Forest Edge Drive from West Division Street to West Park Row Drive from a 4-lane major collector to a 2-lane minor collector.

Upgrade:

1. Abram Street from S.H. 360 to the eastern limit of the City of Arlington from a 4-lane major arterial to a 6-lane major arterial.

Also present in support of this case was Anne Lemmons, 1401 Forest Edge Drive, #11, 76013.


